### 3 . Hazards identification

<b>Hazard information</b>	: Primary Routes of Exposure: Dust inhalation, skin contact.
<b>Inhalation</b>	: Low acute inhalation toxicity. As with exposure to high concentrations of any dust, minimal irritation of the respiratory tract may occur. Exposure not probable with intended use. Chronic: No adverse changes in the lungs result from this accumulation. Exposure not probable with intended use.
<b>Skin contact</b>	: Not an irritant. Low dermal toxicity. Not a dermal sensitizer.
<b>Eye contact</b>	: Toner may act as a mechanical irritant.
<b>Ingestion</b>	: Low acute oral toxicity.

### 4 . First aid measures

<b>Inhalation</b>	: If symptoms, such as shortness of breath or persistent coughing are experienced, remove source of contamination and move individual to fresh air. If symptoms persist, seek medical attention.
<b>Skin contact</b>	: Wash with soap and water. Should irritation occur, seek medical attention.
<b>Eye contact</b>	: Do not rub eyes. Flush immediately with plenty of water. Remove contact lenses and continue flushing for at least 15 minutes. If irritation develops and persists, seek medical attention.
<b>Ingestion</b>	: Do not induce vomiting. Never give anything by mouth to an unconscious person. Get medical attention if symptoms appear.

<b>Personal precautions</b>	: None required for intended use in printer.
<b>Environmental precautions</b>	: Disposal is subject to national, state, regional, or provincial regulations.
<b>Methods for cleaning up</b>	: If a dust cloud is possible due to a spill, remove all sources of ignition such as open sparks, flames, or static discharge to prevent the ignition of the dust. Minimize dust generation during clean up. Sweep up spill with non-metallic broom and dustpan. Contain for disposal. Oil permeated sweeping compound may be useful in cleaning up spills.

## 7 . Handling and storage

- Handling** : Avoid generating dust. To avoid damage to cartridge and accidental contact with toner, keep out of reach of children.
- Storage** : Store in a cool, dry place. Store away from oxidizing material.

- Engineering measures** : Not required. Use in a well-ventilated area.

- Stability and reactivity** : The product is stable.

- Primary routes of exposure** : Inhalation of dust, skin contact.
- Ingestion** : Low acute oral toxicity. Exposure not probable with intended use.
- Acute toxicity oral rat LD50 (mg/kg)** : >5000
- Inhalation** : Low acute inhalation toxicity. As with exposure to high concentrations of any dust, minimal irritation of the respiratory tract may occur. Pure titanium dioxide, a minor component of this product, has been listed by IARC as a group 2B (possible carcinogen). This classification is based on rat "lung particulate overload" studies performed with airborne particulate. Toner is not listed by IARC, NTP, or OSHA.
- Aggravating conditions** : Exposure to high airborne dust concentrations, including toner, may aggravate existing respiratory conditions.
- Potential chronic health effects** : CARCINOGENIC EFFECTS: Classified 2B (Possible for humans.) by IARC [Titanium dioxide].  
MUTAGENIC EFFECTS: Toner is negative (nonmutagenic) in the Ames assay.  
TERATOGENIC EFFECTS: Not available.  
Toner dust is a particulate not otherwise classified (PNOC) or regulated (PNOR).
